ORDINANCE NO. 246
AMENDMENT NO. 1

**AN ORDINANCE REGULATING THE PERMITTING,
LICENSING, AND INSURING OF EACH FIREWORK STAND
SELLING OR OTHERWISE DEALING IN OR WITH FIREWORKS
WITHIN THE MUNICIPAL LIMITS AND WITHIN 5000 FEET OF
THE MUNICIPAL LIMITS OF THE CITY OF SOCORRO, TEXAS**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SOCORRO,
TEXAS, THAT:**

Ordinance 246, entitled "An Ordinance Regulating the Permitting, Licensing, and Insuring of Each Firework Stand or Other Place Selling or Otherwise Dealing in or With Fireworks Within the Municipal Limits and Within 5000 Feet of the Municipal Limits of the City of Socorro, Texas" be and is hereby amended and shall now read as follows:

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SOCORRO,
TEXAS, THAT:**

Section One: All businesses, persons, or other entities selling or otherwise dealing in or with fireworks, other than those businesses, persons, or entity purchasing fireworks for their own use as consumers, situated within the City Limits or within 5000 feet of the municipal limits of the City of Socorro, Texas, shall comply with the terms of this ordinance. Each stand is defined as any non-permanent structure that is independently transported separately and placed at its location regardless of having been connected to any existing or other placed non-permanent structure. Permanent site built structures are specifically excluded as sales stands and shall not be permitted nor licensed to sell or otherwise deal with fireworks. Said fees established by this Ordinance shall be in effect as of the 8th day of December, 2006, and shall apply to any stand now existing or to exist within 5000 feet of the municipal limits and within the municipal limits as a requirement for operation within 5000 feet of the municipal limits and within the municipal limits of the City of Socorro, Texas.

Section Two: Fireworks stand placement shall be restricted to the following locations: a). within 5000 feet of the municipal boundaries of the City of Socorro, Texas; and b). within the municipal limits of the City of Socorro adjacent to Horizon Blvd., between Thunder Road and Interstate 10, and along the Gateway East Blvd within the Socorro municipal limits.

Section Three: Pursuant to Chapter 217, Section 217.041 and Section 217.042, of the Texas Local Government Code, the sales of fireworks within 5000 feet of the municipal limits of the City of Socorro, Texas, is declared to be a common and public nuisance and shall be regulated by the City of Socorro. Said vendors shall comply with all state fire laws applicable to the sale and storage of fireworks.

Section Four: The term fireworks or pyrotechnics means and includes any combustible or explosive composition or any substance or combination of substances or article prepared for the purpose of producing a visible or an audible effect by combustion, explosion, deflagration or detonation, and includes Roman candles, sky rockets, helicopter-type rockets, cylindrical fountains, cone fountains, wheels, illuminating torches and colored fire in any form, sparklers and dip sticks, mines, shells, firecrackers, salutes, whistles without report, squibs, a fire balloon, a hydrogen filled balloon, signal lights, blank cartridges, toy pistols, toy cannons, toy canes or toy guns in which explosives are used, torpedoes, dago bombs or other devices of like construction and any devices containing any explosive or flammable compound or any tablets or other devices containing any explosive substance. However, the term "pyrotechnics" does not include auto flares, paper caps containing not in excess of an average 0.25 of a grain of explosive content per paper cap manufactured in accordance with the regulations for packing and shipping as provided therein and toy pistols, toy canes, toy guns or other devices for use of such caps, the sale and use of which shall be permitted. This Ordinance does not supercede any restrictions placed on the sale of fireworks by El Paso County, Texas, or by the State of Texas.

Section Five: All licensing and inspection fees shall be paid to the office of the City Clerk for the City of Socorro, Texas, at 124 S. Horizon Blvd., Socorro, Texas, 79927. After receipt of said fee a receipt and license shall be issued to the applicant. All fees required by the Fire Marshal for inspections shall be paid directly to the Fire Marshal.

No person shall have, keep, store, or sell any fireworks or pyrotechnics within the City of Socorro municipal limits and within an area extending for a distance of 5,000 feet from the City limits, unless such person shall have obtained a permit from the City Clerk. The application for such permit shall contain the specific location of the structure used to keep, store, or sell the fireworks or pyrotechnics and must also contain a blueprint or diagram showing the construction of such structure. A permit fee of \$750.00 per stand will be assessed.

If a license is lost the fee required to be paid for the issuance of a replacement document is \$50.00.

The license shall expire after the passage of 60 days from the date of issuance.

Section Six: All businesses, persons, or other entity selling or otherwise dealing in or with fireworks other than those businesses, persons, or entity purchasing fireworks for their own use as consumers within the municipal limits of Socorro, Texas, shall secure premises liability insurance in the amount of not less than \$1,000,000.00, and to name the City of Socorro, Texas, as an additional insured, to protect against any losses suffered by the population directly caused by the operation of said ventures or incidents arising therefrom.

Section Seven: Each business, persons, or other entity selling or otherwise dealing in or with fireworks shall clean and maintain the entire parcel of property from trash or fireworks debris upon which the fireworks stand is situated during the times that fireworks are sold and for a period of seventy-two hours after the stands are closed and fireworks are no longer to be sold by operation of state law.

Section Eight: The igniting of fireworks within the municipal limits of the City of Socorro, Texas, is prohibited unless approved by special permit authorized by the Socorro City Council.

Section Nine: It is the duty of the Socorro Police Department, Socorro Code Enforcement Officer and Fire Marshal to inspect all businesses, persons, or other entities selling or otherwise dealing in or with fireworks, and to cite those businesses, persons, or other entities not in compliance with this Ordinance, Building or other Codes adopted by the City of Socorro, or with the State and Local Fire Codes applicable to fireworks stands, within the municipal limits or within 5000 feet of the municipal limits of the City of Socorro, Texas.

Section Ten: Violation of this Ordinance is a misdemeanor subject to a fine up to \$500.00. Each day that a business, person, or other entity remains in violation of this Ordinance constitutes a separate offense.

If any section of this Ordinance shall be adjudged invalid or unconstitutional, the same shall not affect the validity of this Ordinance as a whole or any part or provision thereof other than the part so decided to be invalid or unconstitutional.




